Supporting the tradition of St. Vincent's in caring for the sick and less fortunate, this annual charity golf tournament was created utilizing the experience of our organizations, to establish a premier event for sponsors and participants. The two-day tournament has been designed to maximize the playing experience on both THE PLAYERS Stadium Course and Dye's Valley Course, while giving sponsors and players the opportunity to showcase their commitment to one of the area's most worthy causes.

- **Daily's THE TRADITION** is a 36 hole, two-day tournament, consisting of 72 two-person teams, contested on both TPC Sawgrass courses.
- The format is called a "shamble". Each team member hits a tee shot. They select the best position and each member plays his/her own ball from that preferred location for the remainder of the hole. Tournament rules will stipulate when to use a net best ball or combined net score. Your team strategy will be essential. There will be gross and net awards, but the overall champions will be the lowest team net score.
- Awards will also be given to the daily gross and net winning teams as well as individual proficiency awards.
- USGA handicaps will be required (Handicap Committee will verify USGA handicaps). For players without a USGA handicap, the Peoria system will be used.

- health and nutritional education and counseling
- disease management for those suffering from chronic diseases like asthma, hypertension, diabetes and cardio-vascular conditions
